It is brought to your kind notice that in view of COVID-19 Pandemic outbreak, Madurai Kamaraj University is conducting April 2020 online Examinations for students who have arrears in previous semesters and July 2020 Supplementary Online Examinations for Under Graduate / Post Graduate / MCA Courses for the benefit of the students who have written and failed in the subjects listed for the previous semester and end semester.

I am by direction to inform you that the following students are eligible to appear the above examinations.

1. For the final year students of UG / PG and MCA those who have arrears / absent in the April-2020 end Semester online Examinations shall eligible to appear this examinations.
2. If any final year arrear student not accepting minimum pass awarded in April-2020 Examinations shall be eligible to apply for appearing this Supplementary / Special Examinations July 2020.
3. For the intermediate students those who have arrears / absent in previous Semesters of UG/PG and MCA Programme shall eligible to appear this Examinations if they are interested.
4. If any intermediate arrear students not accepting the marks awarded by conversion shall be eligible to apply for appearing this Supplementary / Special Examinations July 2020.



5. For the Private candidates admitted after 2008 those who have arrears in UG/PG (under CBCS pattern) shall eligible to appear this Examinations.
6. Advise the students to submit the Examination Application with prescribed fee if not submitted earlier and such students shall be permitted to appear this Examinations.
7. If any final year student who was absent / has scored "Zero mark" in internal in the immediate previous Semester (s) shall compulsorily appear in this examination be conducted during November 2020.
